INFORMATION SHEET FOR THE FINANCIAL DISCLOSURE FORM

The following notes is a guide to assist with completing the attached Financial Disclosure form (Appendix C):
NOTE 1
Shares and other financial interests
Designated employees are required to disclose the following details with regard to shares and other financial interests held in any private or public company or any other corporate entity recognized by law:
<ul> <li>The number, nature and nominal value of shares of any type;</li> <li>The nature and value of any other financial interests held in any private or public company or any other corporate entity; and</li> <li>The name of that entity.</li> </ul>
NOTE 2
Directorships and partnerships
Designated employees are required to disclose the following details with regard to directorships and partnerships:
<ul> <li>The name and type of business activity of the corporate entity or partnership/s; and</li> <li>The amount of any remuneration received for such directorship or partnership/s.</li> </ul>
Directorship includes any occupied position of director or alternative director, or by whatever name the position is designated.
Partnership is a legal relationship arising out of a contract between two or more persons with the object of making and sharing profits.

## NOTE 3

Remunerated work outside the public service (All remunerated employment must be sanctioned prior to the work being done.)
Designated employees are required to disclose the following details with regard to remunerated work outside the public service.
<ul> <li>The type of work;</li> <li>The name and type of business activity of the employer; and</li> <li>The amount of the remuneration received for such work.</li> </ul>
Remuneration means the receipt of benefits in cash or kind.
Work means rendering a service for which the person receives remuneration.
NOTE 4
Consultancies and retainerships
Designated employees are required to disclose the following details with regard to consultancies and retainerships:

- The nature of the consultancy or retainership of any kind;
  The name and type of business activity, of the client concerned; and
  The value of any benefits received for such consultancy or retainerships.

NOTE 5
Sponsorships
Designated employees are required to disclose the following details with regard to sponsorships:
<ul> <li>The source and description of direct financial sponsorship or assistance; and</li> <li>The value of the sponsorship or assistance.</li> </ul>
NOTE 6
Gifts and hospitality from a source other than a family member
Designated employees are required to disclose the following details with regard to gifts and hospitality:
<ul> <li>A description and the value and source of a gift with a value in excess of R350;</li> <li>A description and the value of gifts from a single source which cumulatively exceed the value of R350 in the relevant 12 month period; and</li> <li>Hospitality intended as a gift in kind.</li> </ul>
Designated employees must disclose any material advantage that they received from any source e.g. any discount prices or rates that are not available to the general public.
All personal gifts within the family and hospitality of a traditional or cultural nature need not be disclosed.

NOTE 7

## **Land and Property**

Designated employees are required to disclose the following details with regard to their ownership and other interests in land and property (residential or otherwise both inside and outside the Republic):

- A description and extent of the land or property;The area in which it is situated; and
- The value of the interest.
